

CHARTER TOWNSHIP OF HAMPTON

ORDINANCE NO. 34

TRAFFIC ORDINANCE

An Ordinance to adopt by reference the Uniform Traffic Code for Michigan Cities, Townships and Villages.

THE CHARTER TOWNSHIP OF HAMPTON, BAY COUNTY, MICHIGAN, ORDAINS:

SECTION 1. SHORT TITLE

This Ordinance shall be known and cited as the Traffic Ordinance.

SECTION 2. ADOPTION OF CODE BY REFERENCE

The Uniform Traffic Code for cities, townships and villages promulgated by the Commissioner of State Police on February 14, 1958, and published in Supplement No. 13, and as amended on February 14, 1961, and published in Supplement No. 25, and on February 26, 1968 and published in Supplement No. 54, and on July 20, 1976 and published in Supplement No. 88, and on February 10, 1978 and published in Supplement No. 94, to the 1954 Michigan Administrative Code, in accordance with Public Act 62 of 1956, State of Michigan, is hereby adopted by reference as in this Ordinance modified.

SECTION 3. CODE MODIFIED

References in the Uniform Traffic Code for Michigan cities, townships and villages to "governmental unit" shall mean the Charter Township of Hampton, Bay County, Michigan.

SECTION 4. PUBLICATION OF NOTICE

The Charter Township of Hampton Clerk shall publish this Ordinance at the same time and in the same manner as the publication of the minutes of the Township's regular meetings, at which meetings this Ordinance is introduced and

adopted, and the Clerk shall, at the same time and in the same manner, publish a supplementary notice setting forth the purpose of the said Uniform Traffic Code and of the fact that complete copies of the Code are available at the office of the Clerk for inspection by and distribution to the public at all times.

SECTION 5. CONFLICTING ORDINANCES REPEALED

All other ordinances, inconsistent with the provisions of the Uniform Traffic Code, are, to the extent of such inconsistency, hereby repealed.

SECTION 6. EFFECTIVE DATE

The Uniform Traffic Code will be in effect in the Charter Township of Hampton, Bay County, Michigan, on the 31st day after publication following adoption as required by law.

NOTICE OF ADOPTION OF UNIFORM TRAFFIC CODE


Notice is hereby given that pursuant to the provisions of Act 62 of the Public Acts of 1956, State of Michigan, as amended, the Uniform Traffic Code for cities, townships and villages was adopted by reference by the Charter Township of Hampton, Bay County, Michigan, on the 26th day of June, 1978.

The purpose of such Code is to regulate the operation of vehicles, to provide for the regulation and use of streets, highways and alleys and other public and semi-public places within the Charter Township of Hampton, Bay County, Michigan, and to provide penalties for the violation of said Code.

Complete copies of the Uniform Traffic Code are available at the office of the Charter Township of Hampton, Clerk, for inspection by and distribution to the public at all times.

No further or additional publication of the Uniform Traffic Code is required or contemplated.
