

## NOTICE OF PUBLIC HEARING

TO: THE RESIDENTS AND PROPERTY OWNERS OF THE CHARTER

Notice is hereby given that the Hampton Township Planning Commission will hold a public hearing on **Thursday, October 13, 2022 at 7:00 p.m.** in the meeting room of the Hampton Township Hall, 801 West Center Road, Essexville, Michigan 48732, to consider at the request of the applicant, Fisher Contracting, on behalf of Paul and Cynthia Rivard, owners of the below-described property, for a special use permit which would allow it to construct and maintain a pond on property currently zoned low density residential district (R-2) within the Charter Township of Hampton, County of Bay, State of Michigan. Under the Zoning Ordinance, ponds are permitted in said zone only by special use permit, granted by the Planning Commission following hearing.
